Welcome to the Osceola County Fairgrounds. We are a licensed campground, open year round for camping. There are restaurants, shopping and a grocery store within walking distance. We offer clean, well maintained bathrooms and showers, clean grounds, friendly and helpful staff.

### **Rules and Regulations for Wood Carvers, Dulcimer and Fair Camping**

1. Camping is \$2000 a night w/electric. \$17.00 primitive.
2. Camping is on first come basis-no reservations.
3. No refunds after 10:00 A.M. daily and no refunds at all after Friday at 10:00 A.M.
4. A vehicle permit is required Dulcimer week to enter the campground and must be visible in the vehicle front windshield.
5. Campsites are limited to one recreational unit, one small tent (same family) and one vehicle per site. All others must park outside the gates.
6. Campers may not set up on a lot until checked in at the office.
7. Campers shall not move from assigned sites unless authorized by the fair office.
8. Parents are responsible for the safety and supervision of their children. Parents please advise children to respect the rights and privacy of other campers by not cutting through campsites.

9. For safety reasons, NO bikes are allowed during Wood Carvers, Dulcimer Festival and Fair Week.
10. No ORV or golf carts are allowed in the campground unless authorized by the Fair office.
11. Garbage shall be disposed of in containers provided by the fairgrounds.
12. Upon leaving the fairgrounds, your campsite shall be left neat and clean.
13. No campfires unless in a free standing fire pit.
14. No dumping of household garbage in containers provided by the fairgrounds.
15. No liquid waste of any kind, such as sink, lavatory, and showers shall be discharged onto the surface of the ground.
16. No persons shall dispose of disposable diapers, paper towels or sanitary napkins into the toilets.
17. All dogs shall be under control and at your campsite on a leash not to exceed 6 ft. Dogs may be walked to the nearest exit for bathroom breaks and directly back to the campsite. Owners will be responsible to clean up after their pets and dispose of it properly. Animals creating a disturbance or running loose will be removed from the fairgrounds
18. It is unlawful to destroy or remove Osceola County Fairgrounds property or equipment.
19. Generators are allowed but please be respectful of your neighbor and not run late at night, all night or early morning.
20. No person or persons shall take it upon themselves to tamper with any water lines or electrical systems. NO burying of any lines.
21. All fairground rules will be enforced. Failure to comply after being contracted by the fairground officials, you may be asked to leave the fairgrounds.
22. No drugs or alcohol allowed.
23. All complaints shall be directed to the fair office.
24. Fair campers are not allowed to drive personal vehicles to the barn area to feed animals during fair week.
25. No animal washing anywhere except at designated wash racks.
